Chapter 2256.023, Government Code (The Public Funds Investment Act), requires the investment officer of each local government to submit to its governing body a quarterly report of investment transactions.

The attached report details investments for Victoria County, Citizens Medical Center and Victoria County Navigation District for the quarter ending September 30, 2020.

Portfolios total \$122,979,018.38 and are invested with an emphasis on safety, liquidity and yield. The portfolio for the quarter was invested in LOGIC Pool 4.29%, Certificate of Deposits 9.53% and 86.18% in cash with an average interest rate of .866%.

Federal Reserve Bank did not change the Fed Fund interest rate this quarter and it is predicted to stay the same for some time. Currently the Fed Funds interest rate is 0.00 to 0.25%. Investment cash accounts at Prosperity Bank earned an average .187% for the quarter.

Pledged collateral of bank deposits, held by Prosperity Bank, is monitored and above limits required by our depository contract.

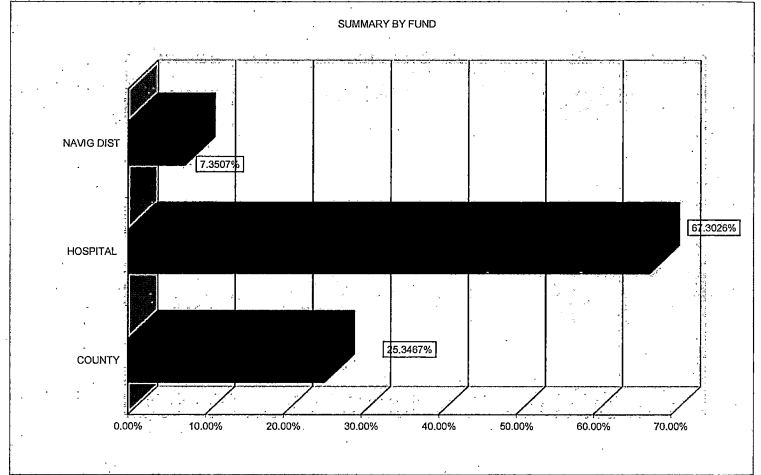
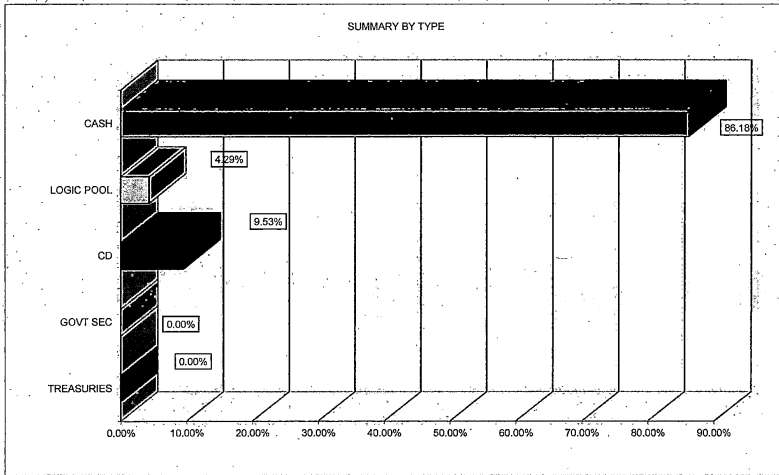
