

## MISCELLANEOUS FEES

### PERMIT APPLICATION

EFFECTIVE 01-01-2026

The following fees apply to obtaining permits from the Victoria County Fire Marshal's Office. Acceptable payment methods are paper checks or money orders made payable to Victoria County, or a credit card. Payment must be submitted before starting the process for which the fee applies. Please note that all fees paid to the Victoria County Fire Marshal's Office are non-refundable. A submission is not considered complete until all required documentation, including payment, has been received. For commercial building permits, the total fee consists of three parts: the plan review fee, the building permit and inspection fee, and the final inspection and Certificate of Compliance fee.

<input type="checkbox"/>	<b>Re-Inspection</b> <b>A re-inspection fee must be paid before rescheduling the next inspection. This fee also applies if you fail to show up for a scheduled fire inspection without notifying us in advance, or if you do not cancel the inspection at least half a business day before the scheduled date and time. Fee for 1<sup>st</sup> re-inspection is \$50, 2<sup>nd</sup> re-inspection is \$75, 3<sup>rd</sup> and each subsequent re-inspection is \$100.</b>

Once the permit application is completed, please return it, along with the required payment and project plans saved on a USB drive in a single PDF format, to the Victoria County Fire Marshal's Office. It's important to note that submitting the permit application and plans does not mean you are approved or authorized to begin construction. Applicants must wait to receive the stamped, approved plans from the Fire Marshal's Office before starting any work. If construction begins before approval is received, a fee for working without a permit will be charged.
